Greetings from the University of Iceland!

We are starting to process incoming nominations for the autumn 2019, for applicants from countries outside of EU/EEA and therefore send this reminder on our deadlines and process. Please be aware that if you have a student from a country outside of EU/EEA who has a residence permit in your country, this still requires the student to apply for a student permit in Iceland with the Directorate of Immigration and therefore the Non-EU/EEA nomination and application deadlines apply.

The University of Iceland uses an online nomination system for incoming exchange students (see Fact sheet attached).

Applications from your students to the University of Iceland can only be considered if you nominate them using this link. **Please do not forward the link to your students**

International coordinators nominate their students online **at least two weeks** before the application deadline.

Nomination deadlines:

Autumn semester

Non-EU/EEA citizens: 15 February
EU/EEA citizens: 15 April

Spring semester

Non-EU/EEA citizens: 15 July
EU/EEA citizens: 15 September

Exchange students application deadlines:

Autumn semester

Non-EU/EEA citizens: 1 March
EU/EEA citizens: 1 May

Spring semester

Non-EU/EEA citizens: 1 August
EU/EEA citizens: 1 October

Non-European citizens need to apply for a student residence permit to be able to study in Iceland. Applying for this permit can take considerable time. We strongly advice students to start acquiring documents for their student permit as soon as they have received their application information. Students must also make sure that they apply for their student permit within the deadline of the Directorate of Immigration as well as making sure that they submit all the correct documents.

The reason we emphasize this is the fact that we have received students that have not applied in time or with the wrong documents and this has created problems for them which could easily have been avoided.
