Dear Partner

I hope that you are well and coping with these challenging times. I am writing to advise you of recent developments at Loughborough University with regard to the operation of inbound and outbound study exchanges in the academic year 2020/21.

For inbound exchanges, the campus will be open, and we look forward to welcoming your students. We shall be running a full teaching timetable for all of our degree programmes which will include face-to-face tuition, laboratory practical work (if applicable) and a stimulating learning environment. Where there are large groups of students in a lecture, it is likely that UK Government guidelines will require online delivery in the first instance. Any lectures that are delivered online will be accompanied by the opportunity for students to ask questions and interact with staff.

Students wishing to apply for a Semester 1 or Full Year study exchange should submit their application forms by **30 June 2020**, and students wishing to apply for Semester 2 should submit their application forms by **15 November 2020** (see <https://www.lboro.ac.uk/study/overseas-exchange/incoming/applying/how-to-apply/>).

Please note that on arrival in the UK, travellers must:

- state their destination and provide their contact details;
- stay at the same address for the first 14 days except in very limited situations (known as 'self-isolating').

If there is no change to this guidance over the coming months, inbound students will need to take this into consideration when planning their travel and, of course, ensure that they follow any advice provided by the Government in their home country.

For outbound exchanges, Loughborough students will be required to follow UK Government advice, which currently advises against non-essential travel. However, we hope that restrictions will be lifted over the coming months so that our students can travel to their chosen destinations. Loughborough University has, however, taken the decision not to allow its students to participate in exchanges if the teaching and learning provided by the host institution is wholly online.

I hope that this clarifies the University's current position, and I shall of course continue to monitor the situation and keep you informed. In the meantime, however, I would like to take this opportunity to thank you for keeping us informed of developments at your own institution.
