Statutes of 10th October 2015 amending the Doctoral Degree Regulations of the Faculty of Education of Technische Universität Dresden dated 24th November 2010 (published in the official announcements of TUD No.: 7/2010)

Based on §§ 41, 88 para. 1 No. 2, 13 para. 4 sentence 1 of the Act on the Autonomy of Institutions of Higher Education in the Free State of Saxony (Sächsisches Hochschulfreiheitsgesetz - SächsHSFG) of 10th December 2008 (Saxon Law and Official Gazette [SächsGVBI] p. 900), in the version of the announcement of 15th January 2013, the Faculty of Education of Technische Universität Dresden issues the following amendment statute.

Article 1 Amendment of the Doctoral Degree Regulations

The Doctoral Degree Regulations of the Faculty of Education of Technische Universität Dresden of 24th November 2010 shall be amended as follows:

- 1. The words "In exceptional cases, in particular" shall be inserted at the beginning of § 3 para. 1, sentence 4. The words "TUD Young Investigators of the Faculty" are to be inserted after "may also" and the words "or qualified scientists" after "higher education lecturers".
- 2. In § 5, para. 2, no. 2, the words "or a TUD Young Investigator" are to be inserted after the words "higher education lecturer".
- 3. In § 5 para. 4, the following is to be inserted after the first sentence: "The doctoral student is supervised by a higher education lecturer or a TUD Young Investigator of the Faculty (academic supervisor). The academic supervisor and the doctoral candidate must sign a supervision agreement based on the recommendations of the DFG or the Graduate Academy of Technische Universität Dresden".
- 4. § 7 para. 2 shall be amended as follows: "The doctoral thesis shall be evaluated by two examiners. One of the examiners must be an appointed professor at a university according to § 60 or § 62 SächsHSFG. The other examiner may be a TUD Young Investigator of the Faculty, a professor at a university of applied sciences or a junior professor, or must at least prove post-doctoral achievements".
- 5. The following new paragraph 3 shall be inserted in § 8: "Deviating from para. 2, a cumulative doctoral thesis may also be submitted. This consists of a content-wise

continuous argumentation, into which already published texts of the documentary are worked in completely or in excerpts". The original paragraph 3 shall become paragraph 4 and the subsequent numbering of the paragraphs and the references in the order concerned shall change accordingly.

Article 2 Entry into force and transitional arrangements

This statute is published as part of the official announcements of Technische Universität Dresden and comes into force one day after its publication.

All doctoral projects starting after its entry into force must be carried out according to these regulations. Decisions on the acceptance of a doctoral candidate, which have already been taken before the entry into force of this regulation, shall remain valid; in addition, however, this regulation shall apply. Doctoral procedures already opened at the time of entry into force of this regulation shall be completed based on the provisions of the doctoral regulations of the Faculty of Education of 24th November 2010.
