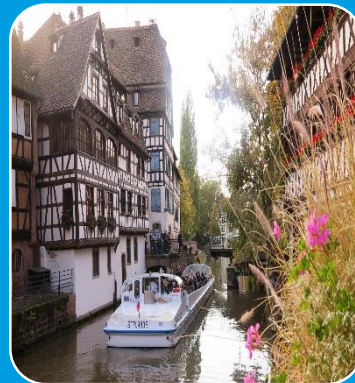

4.2. Scholarships

Tuition Waiver TUD

- Application between 1st June and June 15th/1st February and 15th February

Tuition reduction partner universities

- One partly waiver for each university
- Application between 1st June and June 15th

Society of Friends and Supporters of TU Dresden (GFF)

- Up to 300 EUR/month (only at TUD)
- Up to 5 scholarships

Erasmus+

- Possible for students in Prague (7), Strasbourg (7) and Tallinn (4); 490/540 EUR/month

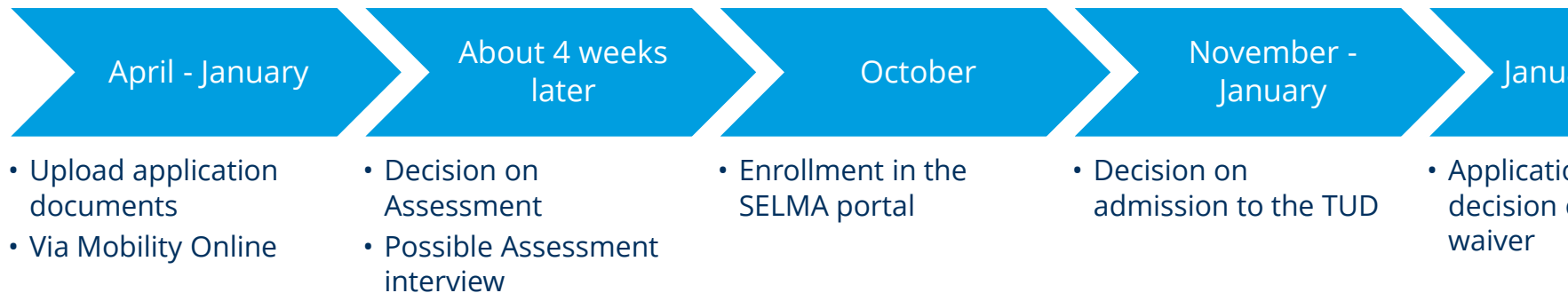

Language requirements	English C1 (TOEFL or IELTS) (French B2 – Strasbourg) No German language required
Motivation letter	Motivation for IP/IT
