## The War in Syria and the Fall of Bashar al-Assad

In 2011, one of the most devastating humanitarian crises of the 21st century began with the Syrian civil war. Rebel groups attempted to overthrow the long-standing Assad regime. The Islamic State (ISIL) also became involved in the devastating conflict from 2014 onward, attempting to establish a caliphate on Syrian soil. In combating the insurgents and terrorists, dictator Assad resorted to horrific tactics of warfare and repression, e.g., barrel bombs, the isolation of entire regions from food and essential goods, and torture. Furthermore, various external actors intervened in the conflict, turning Syria, a strategically vital state on the Mediterranean and gateway to the Middle East, into a theater of geopolitics. Russia, steadfast in its support of Assad, carried out widespread military aerial bombings. The USA launched one of the largest anti-terror operations of the past decade, supporting Kurdish rebels in the process. Turkey, also a NATO member like the USA, continuously attacked Kurdish rebels in northeastern Syria, with growing indications that Turkey was actively supporting ISIL to achieve its goals. Amid this chaos of actors, shifting lines of support, and allies and enemies facing off in battle, it was above all the Syrian civilian population that suffered the most. Documented human rights violations – including torture, forced displacement and starvation, and many more – have cast a shadow over the Syrian people.

Yet on November 27, 2024, after a prolonged period of stabilization and consolidation of Assad's dominance despite the ongoing civil war, opposition rebel groups led by Hay'at Tahrir al-Sham launched a large-scale and, for many, unexpected military operation. Just 11 days later, on December 8, 2024, the 54-year-long dictatorial reign of the Assad family came to an end as Assad fled to Russia to seek political asylum which marks a new chapter for Syria. On the one hand, this marks the end of the unprecedented atrocities committed by the Assad regime, which resulted in the loss of hundreds of thousands of lives, forced millions to flee, and threw the country into chaos. On the other hand, it paved the way for the new transitional government, which many see as a symbol of hope for order and stability while others fear it to establish an Islamistic authoritarian, maybe even Taliban-like, regime.

In this seminar, we aim to address this complex situation from a sound legal perspective. After a brief introduction, we will examine the legal implications of Assad's conduct of war. We will then assess the legality of foreign activities and "interventions" in Syria. We will also explore the legal implications of self-determination, as well as the role the international community has played – and should have played – in light of the severe human rights violations committed by various actors in Syria. Finally, we will closely examine the new situation after December 8: Is (or should be) the new transitional government internationally recognized as the legitimate government? What mechanisms for prosecuting Assad and his followers exist under international law or even national law?



The seminar is open to all interested students who are willing to thoroughly engage with the topics and actively participate in the discussions. Prior knowledge of international humanitarian law, international criminal law and international human rights law is highly recommended but not required.
