

Attachment to the supervision agreement Supplementary agreement for a doctorate in cooperation with the private sector (industry-sponsored doctorate)

– Preamble –

Within the framework of a doctorate in cooperation with businesses at TU Dresden, early-career researchers qualify for employment in academia and the private sector. The doctorate constitutes an independent achievement in research that is accompanied and supervised by experienced researchers. TU Dresden holds the responsibility for the doctorate proceedings. The terms of the proceedings are stipulated in the current doctorate regulations of the respective Faculty. As for doctorates in cooperation with businesses, TU Dresden, the participating company, and the doctoral candidate bear collective responsibility for the doctorate.

The following agreement supplements the supervision agreement and ensures a clearly defined scope of action for all parties involved. Furthermore, this attachment should serve as a guideline for the responsible Faculty or for the Doctoral Board (Promotionsausschuss) of the Faculty, which decides on the admission of the doctoral candidate.

The aforementioned persons hereby confirm that they have acknowledged and agree to the following guidelines as well as to the tasks and obligations of the parties involved, and agree to their implementation within the framework of this agreement.

1. Objectives for the doctorate and selection of the research topic

The objective of the doctorate is the completion of an independent academic achievement. The specific research topic of the doctorate must be selected in consultation with the primary supervisor at the university in order to ensure that the chosen topic satisfies the academic requirements of a doctorate and is in line with the specialist area of the primary supervisor. A predefinition of the dissertation topic by the company is inadmissible.

The topic of the doctorate:

was agreed in advance with the supervisor at the university and is of appropriate academic standard.

2. Supervision and mentoring of the doctorate

1. The primary supervisor of TU Dresden is responsible for the academic supervision. The mentor is responsible for the support of the doctorate within the company with regard to the topic of the dissertation. A continuous exchange on the content and progress of the dissertation is to be ensured by all parties. The details of the supervision are regulated in the supervision agreement between the doctoral candidate and the principal supervisor and are supported by the company.
2. The mentor shall promote the timely progress of the dissertation through
 - topic-specific support of the dissertation
 - advice and support on qualification issues and career development
 - ensuring compliance with the scientific quality requirements of TU Dresden
 - assistance in cases of conflict

3. In addition to the regular exchange between the doctoral candidate and the primary supervisor, joint consultations on the status and progress of the doctoral project are held between the doctoral candidate, the primary supervisor and the mentor as well as (if necessary):

3. Provisions for publication and utilisation

1. As the author of the dissertation, the doctoral candidate is entitled to the intellectual property rights for his or her dissertation. All data, sources and methods, which the dissertation is based on, must be accessible and verifiable.
2. The doctoral candidate and the primary supervisor are committed to the Statutes for Ensuring Good Scientific Practice, Avoiding Scientific Misconduct, and Handling Violations of TU Dresden and regulations for dealing with scientific misconduct. The principles are known to the mentor and are to be respected by the company.
3. The publication of the dissertation as scientific qualification work is stipulated by examination proceedings and must take place within the period specified in the respective doctoral regulations³.
4. All participants agree that the presentation and discussion of (interim) results to an expert audience is a fundamental part of scientific work. Therefore, research results should be presented in a suitable form (articles in scientific journals and conference publications with quality assurance, patents) before completing the dissertation. In all publications produced in the course of the dissertation, the doctoral candidate must always mention his:her affiliation to TU Dresden.
