You (m/f/x) will represent and further develop research in the field of drug therapy safety, pharmacoeconomics and epidemiology. In doing so, you will also emphasize the inclusion of gender-dependent or gender-specific aspects in drug therapy. In accordance with the interdisciplinary nature of such a research approach, we would welcome your willingness to cooperate closely with the clinics and institutes of the University Hospital and the Faculty of Medicine as well as the National Center for Tumor Diseases/University Cancer Center (NCT/UCC) and TUD and with the extra-university research institutions. The chair is associated to the management of the Pharmacy Department of the University Hospital Dresden and is scientifically located in the Integrative Center for Pharmacology and Toxicology (IZPT).

You have a research focus in the field of drug therapy safety, documented by corresponding publications and projects, and are already experienced in the management of research and working groups. Your field of research has a clear perspective in the direct translation into clinical practice in the area of supporting therapies through digital media and the utilization of real-world data. Another desirable research focus is the investigation of the influence of pharmaceuticals, both gender-related in application and on the environment. You have a broad scientific network and significant research co-operations.

We are preferably looking for an integrative personality with additional expertise in the field of pharmaceutical analytics. You have experience in conducting clinical trials according to §13 AMG. Accordingly, a position in the Pharmacy Department and in the manufacturing plant of the clinical pharmacy is possible with the appropriate aptitude.

Appointment requirements include a university degree in pharmacy, a doctorate and habilitation or habilitation-equivalent achievements in the subject of clinical pharmacy, a specialist pharmacist in postgraduate degree in clinical pharmacy and proof of extensive teaching experience of several years in clinical pharmacy as well as pharmacoeconomics and epidemiology. Applicants must fulfill the employment qualification requirements of § 59 of the Institutions of Higher Education Act in the Free State of Saxony (SächsHSG). The employment of professors with clinical-pharmceutical tasks is generally carried out within the framework of non-tariff employment contracts with basic remuneration as well as performance and success-dependent remuneration components.

The Faculty of Medicine strives to employ more women professors in academia and research. We therefore expressly encourage women to apply.
