with a five-year contract, to be filled at the earliest possible date.

At the latest in the fifth year, a tenure evaluation will be carried out by an inter-faculty and inter-departmental commission. If the tenure decision is positive and the appointment requirements are met, the candidate will be appointed to a W2 Chair of Public Health with indefinite tenure (full-time position).

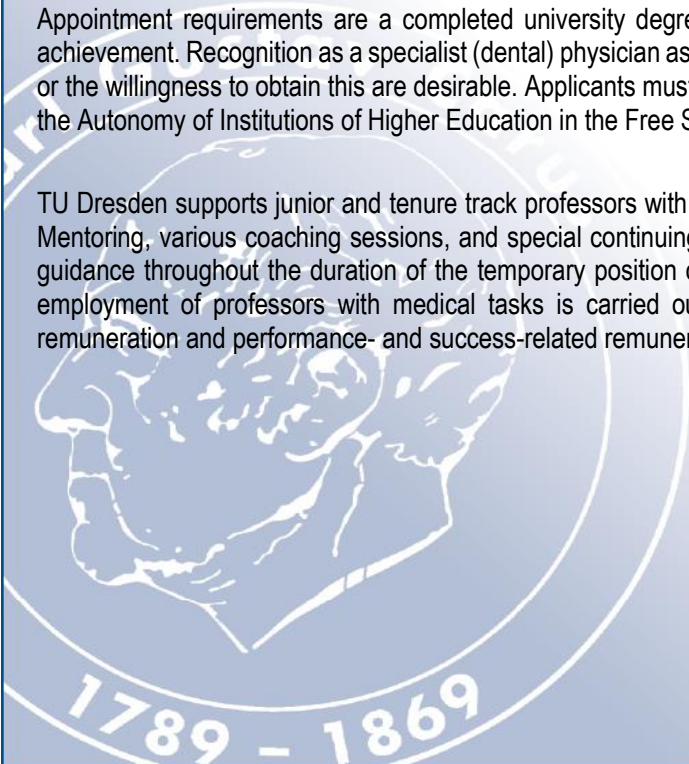
The chair is assigned to the joint Center for Evidence-Based Health Care, where a new teaching and research area "Public Health" is to be established in close cooperation with the Institute and Polyclinic for Occupational and Social Medicine and the Institute for Infectiology and Hospital Hygiene. The close connection to practice is of particular importance. For the duration of the fixed-term contract, you are expected to take up a professional position in the regional public health service (Öffentlicher Gesundheitsdienst, ÖGD) with up to 12 hours of work per week.

The core of the chair is application-oriented health care research in the region as well as in the East Saxon and rural areas. You will be involved in the development and implementation of further education and training programs for the public health service and will work together with the authorities of the public health service in Saxony to increase visibility, professionalism and networking in (scientific) committees, both state-wide and nation-wide, and in line with the principle of "Health in All Policies". You will be involved in teaching, especially in the study of medicine, dentistry and the master's program in health sciences / public health and the bachelor's program midwifery and strengthen the networking of regional partners and the sustainable implementation of innovative concepts of health promotion and prevention in the community setting, environmental medicine and further digitization. Other approaches include research on social compensation in health, addressing health inequalities, linking public health services with curative medicine, taking into account access options (care management).

Tenure evaluation criteria will be mutually agreed upon as part of the appointment procedure. In addition to the quality and quantity of publications and success in attracting third-party funding, key performance criteria for the evaluation will be active participation in larger collaborative or cooperative projects with the regional public health service and in teaching. As a future position holder, you are already known as a research personality in the field of public health research and/or sector-linking health services research and have experience in attracting external funding. Extensive experience and proven publication record in the field of public health research and/or health services research and practical experience in collaboration with the ÖGD are desirable.

Appointment requirements are a completed university degree in medicine or dentistry, doctorate and habilitation or equivalent achievement. Recognition as a specialist (dental) physician as well as the availability of further training authorization for public health or the willingness to obtain this are desirable. Applicants must fulfil the employment qualification requirements of § 58 of the Act on the Autonomy of Institutions of Higher Education in the Free State of Saxony (SächsHSFG).

TU Dresden supports junior and tenure track professors with a program specifically tailored to their needs (YOU PROF program). Mentoring, various coaching sessions, and special continuing education programs and support offers provide active professional guidance throughout the duration of the temporary position of the professorship for the further development of your career. The employment of professors with medical tasks is carried out according to non-pay scale employment contracts with a basic remuneration and performance- and success-related remuneration components.
