The chair is assigned to the Department of Pediatrics (Director: Prof. Dr Reinhard Berner). The aim is to strengthen immunological research with a focus on the pathogenesis of autoinflammation and autoimmunity in childhood and adolescence. The focus here is on linking basic and clinically orientated research into genetically determined defects in the innate immune system. In addition to the elucidation of disease mechanisms, translational perspectives for innovative targeted therapies are to be developed. The chair will also strengthen the research areas 'Immunity' and 'Rare Diseases' within the German Center for Child and Adolescent Health (DZKJ). As part of the chair, we would like you (m/f/d) to cooperate closely with the research networks SFB/TRR 237 'Nucleic Acid Immunity' and SFB/TRR 369 'DIONE - Inflammation-Related Bone Degeneration' as well as the Cluster of Excellence 'Physics of Life' and expect you to successfully acquire third-party funding on your own responsibility. The tasks of the chair also include active participation in teaching, particularly in the field of rare diseases of childhood and adolescence, as well as in the context of gendersensitive medicine. Your extraordinary commitment to the promotion of young scientists and to academic self-administration is also important and welcome.

You have demonstrated independent and outstanding scientific achievements in the field of molecular pathogenesis of diseases of the innate immune system and are recognized both nationally and internationally. In your research and teaching, you also consider and address gender-related aspects in an appropriate manner. We expect a university degree in human medicine, a doctorate and habilitation or proof of equivalent scientific achievements and teaching experience as well as the specialist recognition in pediatrics and adolescent medicine or human genetics. We also expect an international publication record and successful acquisition of third-party funding related to the area of appointment. In all other respects, the requirements for appointment, the official duties and the administrative status are governed by §§ 59, 69, 71 of the Act on Higher Education Institutions in the Free State of Saxony (Sächs-HSG) and the Regulations on Duties and Responsibilities at Higher Education Institutions (HSDAVO).

The Faculty of Medicine strives to employ more women professors in academia and research. We therefore expressly encourage women to apply.
