Chair (W3) of Preventive Work & Life Trajectories

to be filled as soon as possible.

The chair is funded by the Federal Institute for Occupational Safety and Health (BauA) for a period of five years and is assigned to the Institute and Polyclinic for Occupational and Social Medicine (IPAS). After the end of the funding period, the endowed chair will be continued as a chair (W3) at TUD. The chair aims to investigate and further develop evidence-based prevention chains across life phases on the basis of the trajectory concept. The thematic focus of the chair is on relational prevention in the occupational context, whereby the interactions between working and living environments are to be addressed with particular attention to gender-dependent factors. The aim is to develop sustainably effective prevention concepts that can be transferred into practice and take into account aspects of gender-sensitive medicine. Our students are looking forward to your involvement in prevention-related lectures in the Medicine, Public Health, and Midwifery degree programs. In the master's degree program Health Sciences/Public Health, you will be responsible for the compulsory module "Prevention and Health Promotion" and establish a new compulsory elective module "Prevention across Life Phases in Work and Living Environments".

As the future holder of the position, you (m/f/x) are already known nationally and internationally as a prevention research personality through your successful, internationally visible publications and have corresponding experience in the acquisition of public or peer-reviewed third-party funding. You strive for a high degree of collaboration and networking with other chairs at TUD, with national and international research partners as well as with the Federal Institute for Occupational Safety and Health (BAuA) in Dresden and Berlin.

We welcome your experience in the design, coordination, implementation, and evaluation of large epidemiological studies, preferably including prospective cohort studies. Ideally, you have a sound knowledge in the application of both quantitative and qualitative methods (including mixed methods as well as methods of evidence-based medicine, including systematic reviews, prospective meta-analyses). You have a strong commitment to participatory research. You also have relevant and appropriate leadership and management experience as well as experience in dissertation/master thesis supervision.

Appointment requirements are a degree in human medicine (preferably with a specialization in occupational medicine), psychology or health sciences/public health, a doctorate and habilitation or habilitation-equivalent achievements as well as knowledge of university didactics. In addition to the general requirements under public employment law, applicants must fulfil the employment qualification requirements of § 59 of the Institutions of Higher Education Act in the Free State of Saxony (SächsHSG).
