starting **at the next possible date** fixed term until 30.06.2022. The period of employment is governed by Fixed Term Research Contracts Act (Wissenschaftszeitvertragsgesetz-WissZeitVG). The position entails 65 % of the fulltime weekly hours and aims at obtaining further academic qualification.

The CRC aims at investigating trajectories of substance use, studying the underlying cognitive and neural mechanisms, and providing interventions. The position will provide an excellent opportunity to work with some of the leading addiction researches in Germany.

**Tasks:** The candidate will work in the Project 'Moderators of habitual versus goal-directed decision making in human addiction' and will be responsible for participant recruitment, data acquisition, and data analysis. The project aims at developing and implementing new experimental designs to examine habitual behavior with EEG and fMRI methods. The candidate will work in Dresden in the Chair of Tanja Endrass and will closely collaborate with the group of Florian Schlagenhauf at the Charité Berlin.

**Requirements:** university degree (diploma or master) in psychology, cognitive neuroscience, or related fields; a strong interest in cognitive and/or clinical neuroscience; background or interest in neuroimaging and/or electrophysiological methods; fluent English and German.

The CRC and TU Dresden provide an excellent scientific environment. The Chair of Addiction Research has access to the Neuroimaging Center (equipped with fMRI, EEG, TMS, eye tracking facilities) and to the TU Dresden high-performance computing clusters.
