



**DEUTSCHLANDSTIPENDIUM OF THE TU DRESDEN
DECLARATION TO PARTICIPATE AND CONSENT**

I hereby expressly, voluntarily and revocably agree that my personal data is processed by the TU Dresden for the purpose of selection for a Deutschlandstipendium Scholarship and, if applicable, for the purpose of granting a Deutschlandstipendium Scholarship and my data granting the scholarship for a period of six years after the end of the promotion will be saved. In the event that my application is unsuccessful, the data will be stored for one year and, if no renewed application has been received, then deleted immediately.

I am particularly aware that:

1. my personal data can be forwarded to both the responsible for the selection and competent bodies of the TU Dresden as well as to my scholarship sponsor, public and possibly private donors in accordance with § 13 of the Law for the Creation of a National Scholarship Program (StipG), for the purpose of the selection and possible award of the Deutschlandstipendium Scholarship,
2. I can revoke this consent at any time at the Career Service - Deutschlandstipendium of the TU Dresden,
3. If this consent is revoked, my data, if it is no longer necessary for the purpose of proper billing for an already granted Deutschlandstipendium scholarship, will be deleted immediately and the submitted documents will be destroyed in accordance with data protection and the granted Deutschlandstipendium scholarship will not be granted or no longer be granted in this case.

I confirm the accuracy and completeness of the details of my online application. I am aware that in the event of a revocation of the approval notice further promotion cannot take place. I acknowledge that in case of false information the scholarship will be reclaimed in whole or in part. I am aware that there is no legal claim to the Deutschlandstipendium. I undertake to inform the TU Dresden immediately (if necessary, stating the reasons) if I have completed the last examination for my studies, exmatriculate myself, interrupt my studies, cancel my studies or do not start at all or change the university or the course of studies.



ADDITIONAL INFORMATION ON DATA PROTECTION

General information

Your personal data will be treated confidentially and collected and processed solely for the selection of suitable applicants and for the implementation of the Deutschlandstipendium. Your data may be forwarded to the responsible and competent authorities of the TU Dresden as well as to the public and, if applicable, private donors financing your scholarship in accordance with § 13 of the Scholarship Program Act (StipG) for the purpose of selection and any subsequent funding Granting of the Deutschlandstipendium Scholarship. Of course, these persons are bound to secrecy.

The legal basis for this is § 10 StipG. According to this, applicants for the scholarship program are obliged to provide the information required for the examination of the conditions of eligibility and aptitude and to provide the corresponding evidence. Which of these statements you make is up to you: Tell us what qualifies you for the Deutschlandstipendium! We are aware that the information is sometimes highly confidential; some of the information (e.g. about diseases or migration background) are special types of personal data in terms of article 9 DS-GVO. Your data is always treated confidentially and, together with our IT service provider, always protected by the latest technical security measures.

Statistics, evaluation and anonymization

Pursuant to § 13 StipG, we are obliged to submit data to the Federal Statistical Office for granting federal statistics about scholarship holders. This is done anonymously, so without notification of your name.

Samples for the exclusion of a double promotion

The Federal Ministry of Education and Research (BMBF), in accordance with § 4 (2) of the StipG, carries out random checks on the data of the funded students in order to avoid double funding. For this purpose, the BMBF can query name, first name, date of birth, address, university location of individual funded students, save and compare with the data of other sponsoring institutions. The TU Dresden is legally obliged to transmit this data. After the sample has been carried out, the data will be deleted.

For this purpose, the data will be stored for a period of six years after the end of the grant in the case of granting a scholarship. As far as your application in this selection process has no success, we save your data max. 12 months in order to simplify an application in the next selection procedure and, if necessary, to be able to take it into account in a follow-up procedure.
