## Dear members of TU Dresden,

## as of October 27, 2020, a new general ordinance applies for the City of Dresden.

It stipulates concrete steps in accordance with the Corona Protection Ordinance of the Free State of Saxony, which came into force on October 24, 2020.

- 1. According to the updated ordinance, TU Dresden is obliged to collect the following personal data of individuals who visit university buildings in order to ensure the efficient tracing of infections: Name, telephone number or email address, postcode of the home address, and time of visit. The general provisions of TU Dresden have been adapted accordingly.
- 2. This rule does not apply in accordance with the general regulation to short-term visits to buildings. These include, in particular, deliveries and postal collections, etc. The main aim of the regulations is to protect the health of all members of the university. Therefore, this provision must be interpreted in its most narrow sense.
- 3. TU Dresden will collect this data, which will not be accessible to third parties, and store it for one month following the respective visit and subsequently delete it. This data might be requested by the responsible authorities in line with the Corona Protection Ordinance. The procedure has also been agreed upon with the Data Protection Office of TU Dresden.
- 4. The collected data will not be used for any other purpose.
- 5. What does the regulation involve?
  - a. All persons who wish to access the facilities of TU Dresden from October 27, 2020 0.01am onwards, must register in advance using the ZIH tool, which has been set up for this purpose. The link to the ZIH tool will be sent directly via a circular mail in the afternoon of October 26, 2020. Additionally, the link will also be published on the main TU Dresden corona website. They will receive a confirmation of their registration, which they must present upon request by the personnel authorized for this purpose by the University Executive Board when entering the facilities.
    - The members of the university (students, members of staff, including i. university lecturers) should identify themselves by means of their ZIH email address (...tu-dresden.de).
    - Guests should register using a personal email address and name the ii. university member they are visiting, and state the reason for their visit.
  - b. In the coming days, QR codes will be placed on all entrances to the buildings of TUD to enable access to the ZIH tool.

- c. Nevertheless, please register as far as possible before your visit and give the system a few minutes to process your request.
- 6. Supervisors and lecturers must also note the following: Supervisors and lecturers are required to remind everyone to register themselves in the system and they should conduct spot checks.
- 7. The University Executive Board would like to make everyone aware of the consequences of a violation of these regulations:
  - a. It could be a fine for the violation of the <u>Corona Protection Ordinance</u>
  - b. And, a violation of the general provisions of TU Dresden.

We, the University Executive Board, appeal to all members, associate members and guests of TU Dresden to adhere to the regulations. This is important not only for the protection of your personal health, but also as part of your responsibility to the community. We therefore also recommend that you wear a mouth and nose cover in the outdoor areas of the main campus. We would like to cordially thank you for your understanding.

It is our goal to hold the currently planned on-site teaching events during the winter semester, especially with our first-year students in mind. The success of this plan depends on each and every one of us. Please do your bit to help.
