Legal basis for the processing of personal data:

The legal basis for the processing of personal data is Art. 6 (1) sentence 1 lit. a) DSGVO (consent).

Personal data processed, data processing, storage period, and communicating data

Only the contact data provided in the online form will be processed. The data request is necessary for a possible contact tracing in case of a corona suspicion by one of the attendees.

The following personal data will be collected by the cinema in the box and managed for the necessary period of time:

- Email address
- First and last name
- postal code
- City
- Telephone number (optional)

Your personal data will be kept due to the currently applicable corona regulations, for a period of 14 days after the event and then deleted.

The personal data will be stored on the servers of pretix.eu for the indicated period of time. More detailed information about the technical storage on the pretix site can be found at: <https://pretix.eu/about/de/privacy>.

In case the health department requests a contact list from the organizer due to a suspected covid case, the transmitted data (name, email) will be kept for 14 days after the event and released if necessary. At the end of this period, automatic deletion will take place.

Otherwise, no personal data will be transmitted to third parties.

The rights of the persons concerned

In order to exercise your rights, a written notification (email or letter) to the persons responsible is sufficient.

The provision of personal data is voluntary. Consent to the processing of personal data may be revoked at any time with the result that the personal data of the person concerned are not processed further.

The person concerned has the right to request information at any time about the data processed concerning her/him and the possible recipients of such data. S/he may at any time request the TU Dresden to correct or delete her/his personal data or to restrict processing. In the event of a complaint, s/he can contact the supervisory authority in charge of data protection.
